Payment must be made by cash, approved check, bank transfer, Visa or Mastercard. We reserve the right to require certified bank checks for large purchases and to bidders unknown to our firm. We do not extend credit to phone or absentee bidders. **TIME OF PAYMENT** - Payment must be received from successful absentee & phone bidders no later than five working days after receipt of invoice. **COMPLIANCE WITH TERMS OF SALE** - In default of payment of bills in full within the time specified, the auctioneer may retain all monies received as deposit or otherwise, as liquidated damages. Lots not paid for and removed within the time specified may be resold at public or private sale without further notice.
